TERMS AND CONDITIONS OF PARTICIPATION IN THE PRIZE WINNING GAME ORGANIZED BY IPKO TELECOMMUNICATIONS LLC

Article 1 – General Terms and Conditions

Article 2 – Period of organization of the prize winning game

Article 3 – Membership and participation
